



Bargaining Committee Election Announcement

SEIU 1021 - Alameda Health System Chapter (AHS) – RN, GENERAL UNIT
AND SAN LEANDRO CONTRACT

Nominations Open: July 24, 2023

Nomination Period Ends: August 28, 2023

Procedure for Nominations: Nominations shall be in the form of a nominating petition signed by fifteen (15) members in good standing. Members must submit nominations to mrc@seiu1021.org. Once the nomination period ends, on August 28, 2023 and candidate are confirmed, an election will be scheduled.

Listed below are the positions in this election:

General Unit: 20 bargaining seats

RN/APP: 10 bargaining seats

San Leandro: 7 bargaining seats

Time commitment for bargaining committee: The bargaining team term will begin immediately following the vote count on September 14th. Bargaining team will be expected to communicate to members beyond just work hours. The bargaining team will remain elected until ratification of the contract. The chapter board shall retain authority to fill vacancies on the bargaining team.

Eligibility: In order to run for and serve on the bargaining committee, all persons shall be members in good standing, must be a member for one (1) year prior to the election (with exception of newly organized units), and employed within the bargaining unit(s) (including members working out of class) represented by the Chapter. Only members in good standing may participate in the election. Candidates may only run for one (1) seat.

Voting Procedures: Election will be conducted by secret ballots, no proxy votes allowed. A more detailed election procedure shall follow this notice.

Endorsements/Campaign Material: Members may endorse candidates. Such endorsements shall not appear in official election materials of the Chapter or Local publications, only in candidate's materials. Candidates may not use the Local SEIU 1021 in their campaign materials. Candidates may not post campaign materials on SEIU 1021 bulletin boards at worksites.

Election Dates: September 11th, 2023 – September 14th, 2023. Voting will take place at Highland Hospital, John George Pavilion, Fairmont Hospital, San Leandro Hospital, Eastmont, Hayward, Marina and Newark Clinics and 100 Oak Street. Elections will be held between the hours of 7:00 a.m. – 8:30 a.m., 11:00 am – 1:00 p.m. and 3p.m. – 6 p.m. (Detailed election schedule to follow this notice).

Vote Count: September 14th, 2023, starting at 7pm, 100 Oak Street, Oakland, CA

Election Challenges: All challenges to the election submitted in writing by September 18th, 2023 in writing to the AHS Chapter Board, 100 Oak Street, Oakland, CA 94607. The chapter board shall respond within five (5) working days of the receipt of the challenge. Challenges or disputes which are denied or cannot be resolved by the Chapter Election Committee may be appealed in writing to the Local 1021 Chapter Executive Board within five (5) working days of receipt of the Chapter Election Committee's decision. The Local 1021 Chapter Executive Board shall investigate and respond within five (5) working days of receipt of the challenge. Challenges to the election will be considered valid only if they cite specific violations of the Chapter election rules and procedures, Chapter bylaws or the Local 1021 Constitution and if the alleged violation may have affected the outcome of the election.
